In view of the facts and circumstances of the case, there shall be interim Stay of all further proceedings in E.P.No.207 of 2023 in O.S.No.355 of 2016 pursuant to the Order dated 26.02.2026 passed by the learned III Additional Civil Judge (Junior Division), Kadapa thereunder, for a period of Eight (08) weeks.
