

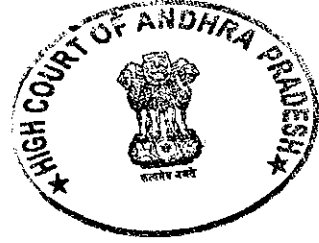

2. The present Contempt Case is filed for non compliance of the Order, dated 09.04.2025 passed by this Court in W.P.No.30406 of 2023.

4. As a last chance, two weeks time is granted to the Respondents to comply with the orders passed by this Court, in default; this Court would be compelled to call for the appearance of the Respondents.
