The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case). The Court made the following

The condition at paragraph No.10 (i) is modified as under:

“The Petitioners/Accused Nos.1 and 3 to 7 shall be enlarged on bail subject to their executing a bond for a sum of Rs.3,00,000/- each with two sureties each for the like sum each to the satisfaction of the learned I Additional District & Sessions Judge-cum-Special Judge for Trial of Offences under NDPS Act, Rajamahendravaram.”

Accordingly, I.A.No.2 of 2026 is allowed.
