G RAMA GOPAL presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the proceedings in Rc.No.2833389/E1/2025-2, dated 10.07.2025 notifying the Final Seniority List of Civil Assistant Surgeon in A.P. Insurance Medical Services by the 1st Respondent is arbitrary and illegal in so far as the placement of the Petitioner at Serial No. 129 instead of Serial No.91 (next below to Serial No.90 Dr. K. Sunil Kumar) consequently direct the 1st Respondent to revise the seniority list dated 10.07.2025 and to give appropriate placement to the Petitioner in the seniority list as per the Merit List dated 23.03.2013 notified by the A.P.P.S.C. pursuant to the notification No.42 dated 29.12.2011 and extend all the consequential benefits i.e., fixation of appropriate pay scale, promotion, etc., to the Petitioner, in the interest of justice

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the

arguments of Sri G RAMA GOPAL Advocate for the Petitioner, GP for Medical & Health for respondent Nos. 1, 3 and 4, G.Seena Kumar, S.C for respondent No.2,directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
