WHEREAS the Petitioners above named through their Advocate Sri ARUN SHOWRI G, presented this Petition under Section 528 of B.N.S.S. (under section 482 of Cr.P.C), praying that in the circumstances stated in the affidavit filed in support of the Criminal Petition, the High Court may be pleased to Quash the may be criminal proceedings against Petitioners/Accused No's.1 to 4 in Cr.No.69 of 2026 of Vedayapalem UPS P.S, Sri Potti Sriramulu Nellore on the file District, registered for the offences punishable under Sections 323, 324, 354, 506, 509 r/w 34 of IPC, r/w 156 (3) Cr.P.C, as they are lacking merits;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri ARUN SHOWRI G, Advocate for the Petitioners, and of Public Prosecutor for Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are be and hereby directed to show cause either appearing in person or through an Advocate, as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

IA NO: 2 OF 2026

Petition under Section 528 of B.N.S.S. (under section 482 of Cr.P.C), is filed praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to stay all further proceedings including arrest of the Petitioners/Accused No's.1 to 4 in Cr.No.69 of 2026 on the file of Vedayapalem UPS P.S, Sri Potti Sriramulu Nellore District registered for the offences punishable under Sections 323, 324, 354, 506, 509 r/w 34 of IPC, r/w 156 (3) Cr.P.C, pending disposal of CRLP No. 3105 of 2026, on the file of the High Court.

The Court made the following ORDER:

Heard learned counsel for Petitioners and learned Assistant Public Prosecutor.

Issue notice to the Respondent No.2.

The learned counsel for the Petitioners is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

Petitioner No.1/Accused No.1 is aged about 44 years, while Respondent No.2 is aged about 42 years. They are wife and husband, and their marriage was solemnized in the year 2014. Respondent No.2 has filed a series of FIRs against the Petitioners. Petitioner No.2 is aged about 76 years and Petitioner No.3 is aged about 70 years; they are the in-laws of Respondent No.2.

Considering the facts and circumstances of the case, and the gravity and nature of the allegations leveled against the Petitioners by Respondent No.2, the matter is referred to mediation.

Mr.Kalisetti Apparao, learned trained mediator is appointed as mediator in this case.

Secretary, High Court Legal Services Committee is directed to issue necessary proceedings in this regard.

The fee for the mediator will be fixed at a later point of time.

Petitioners and Respondent No.2 shall appear before the mediator on 04.05.2026 or any other convenient date for both the parties and the mediator.

The Station House Officer concerned are hereby directed to drive the parties before the learned trained mediator for amicable settlement.

Post this matter along with CrI.P.No.7762 of 2022, CrI.P.Nos.1412 and 4242 of 2023, and CrI.P.No.2571 of 2024, as the issues involved are interconnected. It is further directed that mediation shall be conducted in all the aforesaid Criminal Petitions as well, so that the disputes between the parties may be amicably settled.

For Mediator's report, post after Summer Vacation, 2026.

Until the mediation proceedings are concluded, there shall be stay of all further proceedings in Cr.No.69 of 2026, on the file of the Vedayapalem Urban Police Station, Nellore District.
