Petition under Article 227 of the Constitution of India is filed, praying that in the circumstances stated in the grounds filed herein, the High Court may be pleased to allow the C.R.P. and set aside the Docket Order dated 24.03.2026 in IA. No. 598 of 2026 in COS. No. 1 of 2026 passed by the Honble Principal District Judge at Ananthapuramu and consequently restrain the Respondent/Defendant and his employees, agents, representatives, and all others acting on his behalf from manufacturing, selling, offering for sale, advertising, directly or indirectly dealing in goods services under the trademark/label RAM - G Gold or any other trademark that is identical or deceptively similar to the Petitioners registered trademark amounting to infringement and passing off, until the final hearing and disposal of IA. No. 598 of 2026 in COS. No. 1 of 2026 by the Hon'ble Principal District Judge at Ananthapuramu.
