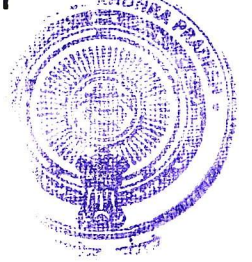

WHEREAS the Petitioner above named through her Advocate
SRI GOURAVARAPU VENKATA LEELE SUNDARAM REDDY presented this
Petition under Article 226 of the Constitution of India is filed praying that in the
circumstances stated in the affidavit filed therewith, the High Court may be
pleased to issue appropriate writ or order or direction more particularly one in
the nature of WRIT OF MANDAMUS to take into the consideration of the
petitioner and declaring the action of the 3rd respondent not considering the

request letters of the petitioner dated 25-02-2026 23-03-2026 for seeking the relief is accept or agree the OTS (One Time Settlement) scheme and grant a three years time for loan repayment amount of loan approximately worth Rupees Rs.3,00,000/- (Three Lakhs Rupees Only) under the OTS (One Time Settlement) scheme to the petitioner and don't harass the petitioner, neighbours and her family members by the 3rd respondent and his/her recovery agents for recovery of monthly EMIs without following the guidelines of the Reserve Bank of India and orders or Judgements had passed by the Supreme Court of India without grant a time to the petitioner to repay the loan amount and pending (EMIs) and the 3rd respondent and his/her recovery agents put a highly pressure against the petitioner, neighbours and her family members as the same is highly illegal arbitrary unconstitutional and violation of the Article 14, Article 19, Article 21 and Article 300A of the Constitution of India and consequently direct the 3rd respondent to consider the request letters of the petitioner dated 25-02-2026, 23-03-2026 for seeking the relief is accept or agree the OTS (One Time Settlement) scheme and grant a three years time for loan repayment amount of loan approximately worth Rupees Rs.3,00,000/- (Three Lakhs Rupees Only) under the OTS (One Time Settlement) scheme to the petitioner and direct the 3rd respondent and his/her recovery agents and don't harass the petitioner, neighbours and her family members for recovery of monthly EMIs and loan repayment amount without following the guidelines of the Reserve Bank of India and orders or Judgements had passed by the Supreme Court of India and other appropriate order or orders may this Hon'ble court deems fit and proper in the circumstances of the case and in the interest of justice, otherwise it will be put irreparable loss and hardship to me

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri GOURAVARAPU VENKATA LEELA SUNDARAM REDDY Advocate for the Petitioner, Central Government Counsel for Respondent No.1 & 2, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
