Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ or direction more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents, especially the Respondents No.3 to 9 herein in not taking action on the report, dated 13-04- 2026 (Grievance No.GNT202604133312), and representation, dated 14-04- 2026) as the same is arbitrary, illegal, unconstitutional of well settled principles of natural justice,

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents No.3 to 9 to take appropriate action on the report, dated 13-04- 2026 No.(Grievance GNT202604133312), representation, dated 14-04-2026 and to pass appropriate order as per law, pending the above writ petition,

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri SARIPUDI RAJA MOULI Advocate for the Petitioner, GP FOR HOME for the Respondent Nos. 1, 4, 5, 6 & 7, GP for Revenue for respondent Nos. 2 , 3 & 8 , GP for Mines for respondent No.9 and the Court made the following.

ORDER

The petitioner is aggrieved by the inaction on the part of respondent Nos.3 to 9 in containing the mining activity by respondent Nos.10 to 17 in the land belonging to the petitioner. In this regard, the

petitioner had submitted a representation seeking action on the illegal mining which is being carried out in the petitioner's land.

The learned Assistant Government Pleader representing the 9th respondent submits that the property of the petitioner is situated away from the area where the mining activity is noticed.

The learned Assistant Government Pleader representing the 8th respondent submits that the Tahsildar personally inspected the premises of the present writ petition schedule property along with the Village Revenue Officer and had noticed that some individuals were digging up the soil.

It is also stated in the instructions that the 8th respondent had advised the said persons not to take up illegal mining. It was also noticed by the 8th respondent that financial disputes between the petitioner's husband and respondent Nos.10 to 17 were brought to the notice of the 8th respondent.

Considering the submissions, there shall be a direction to respondent Nos.3 to 9 to ensure that no illegal mining is taken up without obtaining permission.

The petitioner is permitted to take out personal notice to the respondent Nos.10 to 17 by Speed Post with acknowledgment due and file proof of service in the Registry.

Post the matter on 19.06.2026.
