WHEREAS the Petitioner above named through her Advocate SRI CH B R P SEKHAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any Writ. Order, or Direction, particularly one in the nature of a writ of Mandamus, declaring the action of respondents in not considering the petitioner representation dated 11.02.2026 for promotion to the post of Headmaster Grade strictly in accordance with G.O.Ms.No.56 dated 02.12.2003 and G.O.Ms.No.2 dated 19.02.2020, read with the provisions of the Rights of Persons with Disabilities Act, 2016 and promoting the respondent No.6, Vide proceedings Rc.No. SPL/ZONE-IV/2025, Dated 28.01.2026 is illegal arbitrary, violative of Articles 14 and 16 of the Constitution of India, and contrary to the provisions contained in G.O.Ms.No.56 dated 02.12.2003, and G.O.Ms.No.2 dated 19.02.2020 and The Rights of Persons with Disabilities Act, 2016 and consequently, direct the respondents to set aside the promotion of respondent No.6, proceedings Vide Rc.No. SPL/ZONE-IV/2025, Dated 28.01.2026 and promote the petitioner to the post of Headmaster Grade II in accordance with G.O.Ms.No.56 dated 02.12.2003 and G.O.Ms.No.2 dated 19.02.2020, read with the provisions of the Rights of Persons with Disabilities Act, 2016, along with consequential benefits.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri CH B R P SEKHAR Advocate for the Petitioner, GP FOR REVENUE for respondent no.2, GP FOR SCHOOL EDUCATION for respondent nos.1, 3 & 5 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

may deem fit and proper in the circumstances of the case, , pending disposal of WP No. 10894 of 2026, on the file of the High Court.
