State of Bihar</b><sup>1</sup>, and also with the provisions of Section 35(3) of the Bharatiya Nagarik Suraksha Sanhita, 2023 (for brevity, 'the BNSS'). and the Investigating Officer may proceed with the further investigation. In the course of investigation, if it is noticed that the petitioner has committed any offence punishable with imprisonment beyond seven years, the Investigating Officer is at liberty to proceed in accordance with law.

Considering the nature and gravity of the allegations levelled against the petitioner, the matter is referred to mediation.

Sri CH.Veera Venkata Satyanarayana, learned trained Mediator, is appointed as the Mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The petitioner and Respondent No.2 are directed to appear before the learned Mediator on 04.05.2026 or on any other convenient date for the parties and the Mediator.

The Station House Officer concerned is hereby directed to secure the presence of the parties before the Mediator for amicable settlement.

Post the matter after Summer Vacation–2026, for the Mediator's report.
