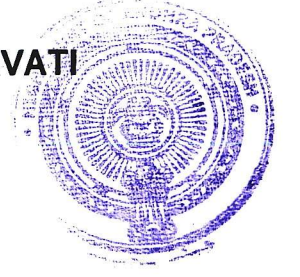

The Court made the following: ORDER:

Issue notice to the Respondent Nos.2 and 3.

The learned Counsel for the Petitioner is permitted to take out personal notice to the Respondent Nos.2 and 3 and file proof to that effect.

Heard the learned Counsel for the Petitioner and the learned Assistant Public Prosecutor.

The learned Principal District and Sessions Judge, Nellore, by order dated 08.10.2025 in Criminal Revision Petition (Nil), directed Respondent Nos.2 and 3 to undergo a DNA test at the Forensic Science Laboratory, Amaravati.

Indeed, there was no necessity to pass such an order. The impugned order does not disclose any reasons, much less valid reasons. In a petition filed for grant of maintenance, issues relating to paternity or maternity have a limited scope.

Considering the facts and circumstance of the case, the order dated 08.10.2025 passed in Criminal Revision Petition (Nil) is hereby suspended until further orders.
