WHEREAS the Petitioner above named through his/her Advocate PULIPATI RADHIKA presented this Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction, more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents herein, more particularly Respondent No.3 4 in not paying the amount of Rs.2,40,199/- under Agreement No.283/18-19 dated 26.06.2018 for the work of Annual Maintenance towards removal of weed growth from Petacalva minor drain between KM 0.00 to KM 5.50 in WUA of Mamilladoddi in G.E.Delta and of Respondents No.5 6 in not paying an amount of Rs.1,01,970/- under Agreement No.134D/2018-1 9 dated 13.12.2018 that is payable to the Petitioner for the work of Removal of weed growth on Ramanayyapeta Channel during Khariff Rabi seasons in 2018-19 as being illegal, arbitrary, unjust and violative of Articles 14, 19(1)(g) and 21 of the Constitution of India and consequently direct the respondents to pay the total amount of Rs. 3,42,169/-, i.e., Rs.2,40,199/- under Agreement No.283/18- 19 dated 26.06.2018 and Rs.1,01,970/-- under Agreement No.134D/2018-19 dated 13.12.2018 along with the applicable interest.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Smt. PULIPATI RADHIKA Advocate for the Petitioner, GP FOR IRRI AND CAD Advocate for the Respondent Nos.1, 3 to 7, GP for Finance and Planning for Respondent No.2, directed issue of notice to the Respondent No.8 herein to show cause as to why this WRIT PETITION should not be admitted.

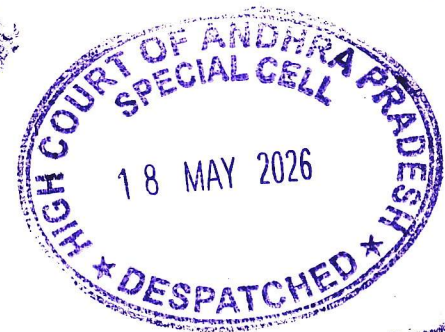
