WHEREAS the Petitioner/Accused above named through Public Prosecutor presented this Petition under Section 528 of BNSS praying that in the circumstances stated in the affidavit filed in support of the Criminal Petition, the High Court may be pleased to quash the Order dated 15.04.2026 passed by the Hon'ble Additional Judicial Magistrate of First Class, Kuppam in Crime No. 76 of 2026 of Kuppam Police Station

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri D.Srinivas, learned Advocate General appearing for the State, directed issue

of notice to the Respondents herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are be and hereby directed to show cause either appearing in person or through an Advocate, as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith(copy enclosed) this **CRIMINAL PETITION** should not be admitted on or before 21.04.2026 to which date the case stands posted for hearing.

IA NO: 2 OF 2026

Petition under Section 528 of BNSS is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to permit the police to arrest the 1st respondent herein i.e., accused No. 1 in Crime No. 76 of 2026 of Kuppam Police Station and to produce him before the Hon'ble AJFCM, Kuppam, pending disposal of CRLP No. 3081 of 2026, on the file of the High Court.

IA NO: 3 OF 2026

Petition under Section 528 of BNSS is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the operation of the Order dated 15.04.2026 passed by the Hon'ble Additional Judicial Magistrate of First Class, Kuppam in Crime No. 76 of 2026 of Kuppam Police Station, pending disposal of CRLP No. 3081 of 2026, on the file of the High Court.

The Court made the following order:

“Issue notice to the Respondent Nos.1 and 2.

The State is permitted to take out personal notice on the Respondent Nos.1 and 2 and file proof to that effect.

Heard Sri D. Srinivas, learned Advocate General appearing for the State/Petitioner.

Ex facie, the impugned orders dated 15.04.2026 and 16.04.2026 respectively, refusing to remand Respondent No.1/Accused No.1 in CrI.P. No. 3081 of 2026 and Respondent No.1/Accused No.2 in CrI.P. No. 3121 of 2026 to judicial custody for a period of 14 days, as requested by the Investigating Officer through the remand report dated 15.04.2026, suffers from two major infirmities.

Firstly, the learned Magistrate failed to take note of the important fact that the Investigating Officer had served notices on Accused Nos.1 and 2 under Section 35(3) of the BNSS, which were refused by them. There is evidence to that effect through the mediators, namely M. Prakash and B.A. Srinivas.

Secondly, the learned Magistrate failed to consider the reasons assigned by the Investigating Officer for arresting the accused, namely that they have been maintaining various social media platforms such as Facebook, Instagram, Twitter, WhatsApp, and fourteen different email accounts, and have been continuously indulging in the alleged offences without any lawful justification.

Indeed, the impugned order does not reflect consideration of these aspects. It appears that the learned Magistrate has mechanically refused to authorize remand and declined judicial custody merely by citing the judgment of the Hon'ble Apex Court in *Arnesh Kumar v. State of Bihar*¹.

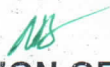
It is also apposite to refer to the judgment of the Division Bench of this Court in Mohammad Jamal v. State of Andhra Pradesh², wherein at paragraphs 7 and 8 it is held that when an accused fails to appear before the police officer or fails to comply with the terms of the notice issued under Section 35(3) of the BNSS, the Investigating Officer is empowered to arrest the accused.

Therefore, the impugned remand orders are liable to be suspended until further orders.
