Petition Under Section 528 of B.N.S.S/Old Under Section 482 of Cr.P.C, is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant of stay of all further proceedings, including the appearance of the petitioner/Accused No.1 in C.C.No. 417 of 2023, on the file of the Addl. Judicial Magistrate First Class, Pithapuram, pending disposal of CRLP No. 3149 of 2026, on the file of the High Court.

The Court made the following: ORDER

“Issue notice to the Respondent No.2.

The learned Counsel for the Petitioner is permitted to take out personal notice to the Respondent No.2 and file proof to that effect.

Heard the learned Counsel for the Petitioner and the learned Assistant Public Prosecutor.

The Petitioner, who is working as a Head Constable, conducted certain proceedings against Respondent No.2 while he was transporting livestock. The said incident was registered as a case in Crime No.172 of 2020. Subsequently, Respondent No.2 filed a private complaint before the

learned jurisdictional Magistrate, which was forwarded to the Station House Officer, Gollaprolu Police Station, for registration of an FIR and investigation. The police registered a case, conducted investigation, and filed a charge sheet against the Petitioner and two others.

Considering the facts and circumstances of the case, there shall be a stay of all further proceedings in C.C. No.417 of 2023 on the file of the learned Additional Judicial First Class Magistrate, Pithapuram, until further orders.
