Petition under Article 226 of the Constitution of India is filed, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the inaction of respondents 2 and 3 in not considering the representations of the petitioner, including PGRS Grievance No. NLR202509151306 dated 15.09.2025, and in failing to act pursuant to the notices issued by the 3rd respondent vide No. B.404/2025 dated 06.12.2025 and 09.01.2026, and in not removing the illegal

encroachment made by the 4th respondent over the Government Cheruvu Poromboke land in Survey No.4 of Kudithipalli Revenue Village, as illegal, arbitrary and violation of the Principles of Natural Justice, and consequently direct respondents 2 and 3 to forthwith remove the fencing and encroachment and restore the petitioner's access for ingress and egress to her agricultural land.

IA NO: 1 OF 2026

Petition under Section 151 CPC is filed, praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct respondents 2 and 3 to consider and act upon the representations of the petitioner, including PGRS Grievance No. NLR202509151306 dated 15.09.2025, and pursuant to the notices issued by the 3rd respondent vide No. B.30.404/2025 dated 06.12.2025 and 09.01.2026, and to forthwith remove the fencing/obstruction created by the 4th respondent over the Government Cheruvu Poromboke land in Survey No.4 of Kudithipalli Revenue Village, or in the alternative provide immediate temporary access to the petitioner for ingress and egress to her agricultural land from the Manubolu-Somasila Highway, Pending disposal of WP 10850 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI V ROOPESH KUMAR REDDY Advocate for the Petitioner, GP FOR REVENUE for the Respondent Nos.1 to 3, the Court made the following.
