Petition Under Section 528 of B.N.S.S/Old Under Section 482 of Cr.P.C, is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay all further proceedings in FIR No.33/2026 on the file of the Mangalagiri Rural Police Station, Guntur District, pending disposal of CRLP No. 3214 of 2026, on the file of the High Court.

The Court made the following: ORDER

“Heard learned counsel for the Petitioners and the learned Assistant Public Prosecutor.

Issue notice to the Respondent No.2.

The learned counsel for the Petitioners is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

The learned counsel for the Petitioners submits that the Petitioner is not a relative of Accused No.1, but he has been arrayed as an accused by Respondent No.2. The Petitioner No.1/Accused No.4 is the sister of

Accused No.1 and the Petitioner No.2/Accused No.5 is the husband of Petitioner No.1.

Considering the facts and circumstances of the case, and the nature and gravity of the allegations leveled against the Petitioners, the matter is referred to mediation.

Ms.K.T.Sudha Sree, learned trained mediator is appointed as mediator in this case.

Secretary, High Court Legal Services Committee is directed to issue necessary proceedings in this regard.

Petitioners and Respondent No.2 shall appear before the mediator for amicable settlement on 29.04.2026.

For Mediator's report, post on 06.05.2026.

The Station House Officer concerned is hereby directed to secure the presence of the parties before the Mediator.

Until the mediation proceedings are concluded, there shall be a stay of all further proceedings in Cr.No.33 of 2026 on the file of the Mangalagiri Rural Police Station, Guntur District."
