Sri T.V.Jaggi Reddy, Advocate for the Petitioner and Public Prosecutor for Respondent No.1, directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are be and hereby directed to show cause either appearing in person or through an Advocate, as to why in the circumstances set out in the petition and the grounds filed therewith (copy enclosed) this CRLP should not be admitted on or before 15.06.2026 for which date the case stands posted for hearing;

IA NO: 1 OF 2026:

Petition under Section 528 of BNSS, 2023 is filed praying that in the circumstances stated in the memorandum of grounds of criminal petition, the High Court may be pleased to stay of all further proceedings including the appearance of the petitioners in C.C No.80 of 2021, on the file of Additional Judicial Civil Judge - Cum - Additional Judicial First Class Magistrate, Tadepalligudem, West Godavari District, pending disposal of CRLP No.3206 of 2026, on the file of the High Court.

The Court made the following:

ORDER:

Heard the learned counsel for the petitioner and the learned Assistant Public Prosecutor.

Issue notice to respondent No.2.

The learned counsel for the petitioner is permitted to take out personal notice on respondent No.2 and file proof to that effect.

The respondent No.2 filed a private complaint on 27.01.2020, which was referred to the Station House Officer concerned for registration of a crime. Subsequently, the petitioner/accused instituted a suit in O.S. No.76 of 2021 on 18.01.2021 seeking recovery of Rs.10,00,000/- from respondent No.2.

The alleged offence is compoundable in nature and punishable with imprisonment below seven years; therefore, the matter is referred to mediation.

Mr. Murali Mohan Sakuluri, learned trained Mediator, is appointed as the Mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The petitioner and Respondent No.2 are directed to appear before the learned Mediator on 06.05.2026 or on any other convenient date for the parties and the Mediator. The learned trained mediator is also directed to conduct mediation in O.S.No.76 of 2021 on the file of the learned Principal Junior Civil Judge-cum-Judicial First Class Magistrate, Tadepalligudem.

The learned Magistrate of the Trial Court and the Station House Officer concerned are hereby directed to drive the parties before the Mediator for amicable settlement.

Post the matter after Summer Vacation-2026, for Mediator's report.

Until the conclusion of the mediation proceedings, there shall be a stay of all further proceedings in C.C.No.80 of 2021 on the file of

the learned Additional Judicial Civil Judge-Cum-Additional Judicial
First Class Magistrate, Tadepalligudem, West Godavari District.
