Petition under Section 438 (1) of BNSS is filed praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to enlarge the Petitioner on bail by suspending the judgment dt.18-03-2026 passed in CrI.A.No.45/2025 on the file of Hon'ble Principal Sessions Judge, Kadapa, partly confirming the judgment dt.30-06-2025 passed in C.C.No.988/2022 on the file of Hon'ble II Additional Judicial Magistrate of I Class, Kadapa, Pending disposal of CRLRC No.438 of 2026, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case). The Court made the following

ORDER

The present interlocutory application was filed by the petitioner to suspend the sentence imposed vide judgment dated 18.03.2026 passed in CrI.A.No.45 of 2025 on the file of the learned Principal Sessions Judge, Kadapa partly confirming the judgment dated 30.06.2025 passed in C.C.No.988 of 2022 on the file of the learned II Additional Judicial Magistrate of First Class, Kadapa, and enlarge the petitioner/accused on bail, pending disposal of the main Criminal revision case.

Heard the learned counsel for the petitioner and the learned Assistant Public Prosecutor on behalf of the State.

In view of the submissions made, the sentence of imprisonment imposed vide judgment dated 18.03.2026 passed in CrI.A.No.45 of 2025 on the file of the learned Principal Sessions Judge, Kadapa partly confirming the judgment dated 30.06.2025 passed in C.C.No.988 of 2022 on the file of the learned II Additional Judicial Magistrate of First Class, Kadapa, against the petitioner alone is suspended, pending disposal of the Criminal Revision Case on the following conditions:

- i. The petitioner shall be enlarged on bail on executing a personal bond for a sum of Rs.20,000/- (Rupees Twenty Thousand only) with two sureties for a like sum each to the satisfaction of the learned II Additional Judicial Magistrate of First Class, Kadapa.

ii. The petitioner shall appear before this Court as and when directed pending disposal of the revision.
