pleased to suspend the conviction and sentence imposed in Judgment dated 31-01-2023 passed in C. C. In the circumstances, sentence of imprisonment alone is suspended, pending disposal of the Criminal Revision Case, and the petitioner herein shall be enlarged on bail on his executing a personal bond for a sum, of Rs.20,000/- (Rupees Twenty Thousand only) with two sureties for alike sum each to the satisfaction of the learned Judicial Magistrate of First Class, Nandalur, and also on condition of depositing 50% of the cheque amount forthwith. Further, the petitioner shall appear before this Court as and when directed.
