Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, one in the nature of WRIT OF MANDAMUS, declaring the action of Respondent No.4 in not conducting enquiry under Section 5(1) on the application made under Section 4(1) dated 22-12-2025 as illegal, arbitrary and unconstitutional, and consequently direct Respondent No.4 to conduct enquiry under Sections 4 and 5 of the A.P. Rights

in Land and Pattadar Pass Books Act, 1971 and pass appropriate orders within a stipulated time frame, and further direct the respondents to consider the settlement deeds dated 13-02-1999 and 17-02-1999 executed by the father and the grandfather of the petitioner and effect mutation in favour of the petitioner.

IA NO: 1 OF 2026

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct Respondent No.4 not to effect any mutation or alteration in the revenue records relating to the subject lands in favour of any third parties, and further direct the respondents not to issue any 1-B extracts, Pattadar Pass Books or title documents in favour of Respondent No.5, and pass, Pending disposal of WP 10950 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI MEGHANA DULLA Advocate for the Petitioner(s), GP FOR REVENUE Advocate for the Respondent Nos.1 to 4 and the Court made the following.
