Constitution of India is filed praying that in the circumstances stated in the

affidavit filed therewith, the High Court may be pleased Writ of Mandamus declaring the action of in not reinstating and absorbing the petitioner services of the 4th respondent temple and 5th respondent institution namely Srikalahasteeswara Swamyvari Devasthanam/Endowment institutions despite having continuously utilized the service of the petitioner for 24 years as a regularized employee in the temple establishment, as illegal, arbitrary, unjust, unconstitutional, and violative of Articles 14, 16, 21 and 23 of the Constitution of India, and consequently direct the respondents to reinstate/absorb and continue the petitioner in the services of the 4th respondent temple, namely Srikalahasteeswara Swamyvari Devasthanam by paying all the salaries, protection of pay, application of applicable A.P. Revised Pay Scales, admissible salary structure, annual increments, arrears of salary from the date of actual joining and all attendant service benefits.

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of Sri RAMINENI SUDHEER Advocate for the Petitioner, GP for Endowment for Respondent Nos.1 to 3, Sri T.Venu Gopal, Advocate for Respondent No.4, Sri D.Krishna, Standing Counsel for JNTU for Respondent No.6, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
