"In the circumstances, sentence of imprisonment alone is suspended, pending disposal of the Criminal Revision Case, and the petitioner herein shall be enlarged on bail on his executing a personal bond for a sum of Rs.20,000/- (Rupees Twenty Thousand only) with two sureties for a like sum each to the satisfaction of the learned Judicial Magistrate of First Class, Nandalur, and also on condition of depositing 50% of the cheque amount forthwith. Further, the petitioner shall appear before this Court as and when directed."
