under Section 528 of BNSS is filed praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to quash the proceedings in C.C No.1947 of 2026 on the file of the Hon'ble II Additional Chief Judicial Magistrate at Vijayawada, arising out of Crime No.79 of 2025 of Suryaraopeta Police Station, for the offences under Section 85 of BNS and Sections 3 & 4 of the Dowry Prohibition Act, against the petitioners/Accused Nos.1 to 3.

The Court made the following: ORDER

Heard learned counsel for Petitioners and learned Assistant Public Prosecutor.

Issue notice to the Respondent No.2.

The learned counsel for the Petitioners is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

The petitioners are husband and in-laws of the respondent No.2.

Considering the entire allegations leveled against the petitioners and the facts and circumstances of the case, the matter is referred to mediation.

Ms. Jyothi Lakshmi Midthipati, learned trained mediator is appointed as mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The Petitioners and Respondent No.2 shall appear before the mediator on 05.05.2026, or on any other date convenient to both parties and the mediator, and shall co-operate with the mediation proceedings for amicable settlement of the dispute.

The Station House Officer concerned is hereby directed to secure the presence of the parties before the Mediator.

Until the mediation proceedings are concluded, there shall be a stay of all further proceedings in Cr.No.79 of 2025 on the file of the Suryaraopet Police Station.

Post the matter after Summer Vacation-2026, for the Mediator's report.
