Since the alleged offences are punishable with imprisonment of less than seven years, the Investigating Officer is directed to adhere to the procedure contemplated under Section 35(3) of the Bharatiya Nagarik

Suraksha Sanhita, 2023¹ . In the course of investigation, if it is revealed that the Petitioners have also committed any offences punishable with imprisonment of more than seven years, the Investigating Officer may proceed in accordance with law.
