The Court made the following ORDER:

Heard learned counsel for Petitioner and learned Assistant Public Prosecutor.

Issue notice to the Respondent No.2.

The learned counsel for the Petitioner is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

Considering the entire allegations leveled against the petitioner by the respondent No.2 for the alleged offence punishable under section 498-A of the I.P.C. The matrimonial disputes are pending in between the accused No.1 and respondent No.2, the matter is referred to mediation.

Mr. Neeru Mishra, learned trained mediator is appointed as mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The Petitioners and Respondent No.2 shall appear before the mediator on 05.05.2026, or on any other date convenient to both parties and the mediator, and shall co-operate with the mediation proceedings for amicable settlement of the dispute.

The Station House Officer concerned is hereby directed to secure the presence of the parties before the Mediator.

Until the mediation proceedings are concluded, there shall be a stay of all further proceedings in D.V.C.No.02 of 2026 on the file of the Additional Junior Civil Judge, Macherla.

The mediator is at liberty to conduct the mediation proceedings in the matrimonial disputes and also Sec.498-A of IPC and other cases.

Post the matter after Summer Vacation-2026, for the Mediator's report.
