WHEREAS the Petitioner above named, through his Advocate M/s VMR LEGAL presented this Petition under Section 528 of BNSS, 2023 is filed praying that in the circumstances stated in memorandum of grounds of Criminal Petition, the High Court may be pleased to quash the FIR No.252 of 2023 on the file of Tirupathi East Police Station, Tirupathi District for the offences punishable under 420 of Indian Penal Code and Section 5 of Andhra Pradesh Protection of Depositors of Financial Establishment Act, 1999;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of M/s VMR LEGAL for the Petitioner and Public Prosecutor for Respondent No.1, directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

IA NO: 2 OF 2025:

Petition under Section 528 of BNSS, 2023 is filed praying that in the circumstances stated in memorandum of grounds of Criminal Petition, the High Court may be pleased to stay all further proceedings in FIR No.252 of 2023 on the file of Tirupathi East Police Station, Tirupathi District for the offences punishable under 420 of Indian Penal Code and Section 5 of Andhra Pradesh Protection of Depositors of Financial Establishment Act, 1999, pending disposal of CRLP No.4507 of 2025, on the file of the High Court.

The Court made the following:

ORDER:

Issue notice to Respondent No.2.

Learned Counsel for the Petitioner is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

Since the alleged offences are compoundable in nature and are punishable below seven years, the Investigating Officer is directed to serve notice under Section 35(3) of 'the BNSS' to the Accused.

Smt S.V.Bharatha Lakshmi, learned trained mediator is appointed as mediator in this case.

Secretary, High Court Legal Services Authority is directed to issue necessary proceedings in this regard.

Both the parties shall appear before the mediation on 06.05.2026.

The Station House Officer, Tirupati East Police Station shall drive the parties to the mediation.

The learned trained mediator shall file her report within one week thereafter.
