Considering the entire facts and circumstances of the case, the matter is referred to mediation.

Ms.Nalluri Yasodha Kumar, learned trained mediator is appointed as mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The Petitioners and Respondent No.1 shall appear before the mediator on 05.05.2026, or on any other date convenient to both parties and the mediator, and shall co-operate with the mediation proceedings for amicable settlement of the dispute.

The Station House Officer concerned is hereby directed to secure the presence of the parties before the Mediator.

Post the matter after Summer Vacation-2026, for the Mediator's report.
