The said suit was subsequently decreed, and the appellate court has not granted any suspension of the said judgment.

Considering the same, there shall be an interim direction restraining the respondents from interfering with the possession of the petitioner over the suit schedule property in O.S. No.140 of 2008 on the file of the Senior Civil Judge, Bhimavaram.
