Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or orders particularly one in the nature of writ of Mandamus declaring the action of 4th Respondent in threatening to dispossess the petitioner from his house site in an extent 144.44 sq. yards (Plot No. 151) in Approved L.P.No. 4 of 2003, of Yeduruvanipalem Village, H/a. Tanam of Parvada Mandal, Visakhapatnam District without following due process of Law as illegal, irregular and arbitrary and violative of the provisions of Board Revenue Standing Orders, Assigned Lands (Prohibition of Transfer) Act and also offends Article 14, 21 and 300A of the Constitution of India and consequently directed the respondents not to interfere into the peaceful possession and enjoyment of the Petitioner's property extent 144.44 sq. yards (Plot No. 151) in Approved L.P.No. 4 of 2003, of Yeduruvanipalem Village, H/o. Tanam.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to, direct Respondents not to interfere into the house site in an extent 144.44 sq. yards (Plot No. 151) in Approved L.P.No. 4 of 2003, of Yeduruvanipalem Village, H/o. Tanam of Parvada Mandal, Visakhapatnam District without following due process of Law, Pending disposal of WP 9552 of 2019, on the file of the High Court.
