Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ of mandamus or any other appropriate writ, order or direction, declaring the action of the official respondents Nos. 2 to 4, in collusion with the unofficial respondents 5 to 7, particularly respondents Nos. 2 to 4, in threatening the petitioner land and interfering with the peaceful possession and enjoyment of the petitioner over the land in Sy.No.2031-1, admeasuring Ac. 3.66 cents, situated at Kalakada Village and Mandal, Annamayya District, without following due process of law, as illegal, arbitrary and unconstitutional, and consequently direct the respondents Nos. 2 to 4 not to interfere with the petitioners peaceful possession and enjoyment of the said property, except in accordance with law

IA NO: 1 OF 2026

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents, particularly respondents Nos. 2 to 4, not to act in collusion with respondents Nos. 5 to 7 and not to evict the petitioner from the suit schedule property, i.e., land in Sy.No.2031-1, admeasuring Ac. 3.66 cents, situated at Kalakada Village and Mandal, Annamayya District, except by following due process of law, Pending disposal of WP No.10988 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Yadlapalli Sitharamanjaneyulu Advocate for the Petitioner, and of GP for Revenue for the Respondent Nos. 1 to 4, and the Court made the following.

ORDER

The prayer in the writ petition is not to dispossess the petitioner without following due procedure of law basing on the D-Form patta issued by the then Tahsildar, Kalakada village and Mandal, Annamayya District.

The learned counsel appearing for 4th respondent has filed written instructions (forms part of the record) dated 22.04.2026, stating that the said D-Form patta is fabricated document.

There shall be interim direction to the respondents not to take any coercive steps against the subject property.
