Issue notice to respondent No.2.

The learned counsel for the petitioners is permitted to take out personal notice on respondent No.2 and file proof to that effect.

This Court, in Crl.P.No.1189 of 2026, granted stay of all further proceedings in C.C.No.2200 of 2024 arising out of Cr.No.131 of 2024 of Kadiyam Police Station, which was filed at the behest of respondent No.2 therein, who is also respondent No.2 in the present case. The petitioners were arraigned as accused in the very same C.C. No.2200 of 2024.

Considering the entire facts and circumstances of the case, there shall be a stay of all further proceedings in C.C.No.2200 of 2024 on the file of the learned VII Additional Judicial First Class Magistrate, Rajamahendravaram, until the next date of hearing.

List this Criminal Petition along with Crl.P.No.1189 of 2026.
