Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue appropriate writ, direction, order or orders, more particularly one in the nature of writ of mandamus, to declare the action of the Respondents in not regularizing the services of the Petitioners, even though, they are discharging their duties more than 30 years and 20 years, respectively, inspite of regularization of similarly placed persons and also not granting payment of minimum time scale of pay attached to their posts, to the Petitioners on par with the regular Government employees as illegal, arbitrary, unjust, discriminatory, violative of Principles of Natural Justice and also contrary to Articles 14, 16 and 21 of the Constitution of India and contrary to the law laid down by the Hon'ble Apex Court and consequently, direct the Respondents to regularize the services of the Petitioners, as was done in respect of the similarly placed persons, whose services were regularized by the Government vide G.O.Ms.No.270, Health, Medical and Family Welfare (E1) Department, Dated: 07.07.2006 and vide G.O.Ms.No.172, dated

08.05.2006, from the date of their eligibility, in accordance with Law laid down by the Hon'ble Apex Court in Uma Devis Case reported in 2006 (4) SCC Page 1, with all consequential service and monetary benefits, with arrears.

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents to consider the case of the Petitioners for payment of minimum time scale of pay attached to their posts, on par with the regular Government employees, as per the ratio of the orders of Hon'ble Apex Court in State of Punjab Vs Jagjit Singh (2017 1 SCC 148), considering their representations, pending disposal of WP 10814 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Poodattu Amarender, Advocate for the Petitioner and of GP FOR SERVICES I for Respondent Nos. 1 to 4, the Court made the following

ORDER:

"The learned Assistant Government Pleader for Service takes notice for the respondents.

Heard the learned counsel for the petitioners.

This writ petition is filed aggrieved by the impugned action of the respondents in not considering the case of the petitioners for regularization in the existing vacancies of Class - IV employees in the Hostels of 4th respondent's Institution and in not extending the Minimum Time Scale of Pay prescribed for the regular post, despite the petitioners having been discharging the same duties since 1995, which is illegal and arbitrary.

The learned counsel for the petitioners submits that though all the petitioners are working since 1995 and they are entitled for regularization, as was done in respect of the similarly placed persons who were regularized by the respondents through proceedings dated

07.07.2006 and 08.05.2006. But the case of the petitioner was not considered and they are not extended the Minimum Time Scale of Pay, which is contrary to the observations made in the Hon'ble Supreme Court in the State of Punjab and others Vs. Jagjit Singh and others, reported in (2017) 1 SCC 148.

Considering the same, there shall be a direction to the respondents to consider the representation and pay the Minimum Time Scale of Pay to the petitioners in view of the above referred judgment.
