Petition under Section 528 of BNSS, 2023 is filed praying that in the circumstances stated in the memorandum of grounds of criminal petition, the High Court may be pleased to stay of all further proceedings in DVC No.8 of 2024 dated 31.07.2024 on the file of the Additional Junior Magistrate Court at Ramachandrapuram, Dr. B.R. Ambedkar Konaseema District including the appearance of the petitioner, pending disposal of CRLP No.3293 of 2026, on the file of the High Court.

The Court made the following:

ORDER:

Heard the learned counsel for the petitioners and the learned Assistant Public Prosecutor.

Issue notice to respondent No.2.

The learned counsel for the petitioners is permitted to take out personal notice on respondent No.2 and file proof to that effect.

Respondent No.2 filed a petition in H.M.O.P. No.212 of 2024 under Section 13(1)(ia) of the Hindu Marriage Act seeking dissolution of marriage on the ground of cruelty. The said petition was allowed, granting an ex-parte divorce.

Respondent No.2 has also filed a case in Cr.No.169 of 2024 on the file of Ramachandrapuram Police Station on 27.07.2024 for the alleged offences punishable under Section 85 of 'the BNSS' and Sections 3 and 4 of the Dowry Prohibition Act, 1961.

Considering the entire facts and circumstances of the case, the matter is referred to mediation.

Mr.D.Kishore Kumar, learned trained Mediator, is appointed as the Mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The petitioners and Respondent No.2 are directed to appear before the learned Mediator on 06.05.2026 or on any other convenient date for the parties and the Mediator.

The learned Magistrate of the Trial Court and the Station House Officer concerned is hereby directed to drive the parties before the Mediator for amicable settlement.

List this Criminal Petition along with Crl.P.No.3289 of 2026.

Post the matter after Summer Vacation-2026, for Mediator's report.

Until the conclusion of the mediation proceedings, there shall be a stay of all further proceedings in D.V.C.No.08 of 2024 on the file of the learned Additional Junior Magistrate Court, Ramachandrapuram.
