Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of writ of Mandamus to declare the delay and inaction on the part of respondent Nos.2 to 11 in initiating necessary action against respondent No.12 and others for committing illegal mining, theft of soil and selling the same to the Brick Industries without obtaining any prior permission as arbitrary, illegal and consequently direct the respondent Nos.2 to 11 to initiate action against respondent No.12 and others immediately for committing the illegal mining, theft of red soil from Rangaraja Cheruvu, Boilakuntla village, Sirvel mandal, Nandyal District and selling the same to the Brick Industries in the interest of justice.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondent Nos.2 to 11 to initiate action against respondent No.12 and others immediately for committing the illegal mining, theft of red soil from Rangaraja Cheruvu, Boilakuntla village, Sirvel mandal, Nandyal District and selling the same to the Brick Industries, pending disposal of WP.No.12901 of 2022, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated 02.05.2022 made herein and upon hearing the arguments of SRI.P.NAGENDRA REDDY Advocate for the Petitioners, learned Government Pleader for Mines & Geology for Respondent Nos.1 to 3, Sri.V.Vinod K.Reddy, learned Standing Counsel for Respondent No.4, learned Government Pleader for Irrigation for Respondent Nos.5 & 6, learned Government Pleader for Revenue for Respondent Nos.7 & 8, learned Government Pleader for Home for Respondent Nos.9 to 11, the Court made the following.
