WHEREAS the Petitioner above named through his Advocate Sri K.Jyothi Prasad presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit

filed therewith, the High Court may be pleased to issue a WRIT OF MANDAMUS declaring the action of the respondents, particularly the 5th respondent, in issuing Proceedings in Rc.No.DEO/1050/2019-SA(MIEXM)-DEOVSP, dated 21/01/2026, whereby the petitioner was removed from service as School Assistant (Maths), Zilla Parishad High School, Islampeta, Pedagantyada Mandal, Visakhapatnam District, basing on the conviction in a criminal case, without properly considering the explanation submitted by the petitioner and without appreciating the pendency of Criminal Appeal and the interim order of suspension of sentence granted by this Hon'ble Court, as illegal, arbitrary, malafide and violative of the Principles of Natural Justice besides violation of Constitutional Guarantees and consequently to set aside the same by directing the respondents to continue the petitioner in service as School Assistant (Maths), Zilla Parishad High School, Islampeta, Pedagantyada Mandal, Visakhapatnam District;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri K.Jyothi Prasad, Advocate for the Petitioner and of GP for Education for Respondent Nos.1 to 5, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
