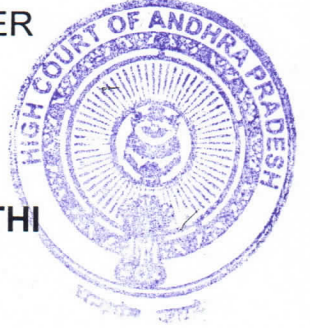

Division); Nandyal, Kurnool District, A.P , Pending disposal of CRP No. 1085 of 2024, on the file of the High Court.

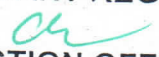
