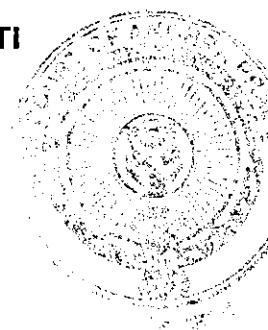

On 29.04.2022, this Court granted the interim order that "Meanwhile, respondents are directed not to take any further steps pursuant to the proceedings Rc.TBPOVII-UC No.03/2019 dated 14.08.2021 and 28.04.2022. Interim order was extended but on 20.09.2022, it could not be extended.

Sri G.Naresh Kumar, learned counsel, representing Sri M.Manohar Reddy, learned Standing Counsel for the respondent Nos.2 and 3, submits that the impugned proceedings have not been given effect till today.

In view of the above, the interim order dated 29.04.2022 is extended till the next date of listing.

I.A.No.3 of 2022 stands disposed of finally."
