Heard learned counsel for Petitioner and learned Assistant Public Prosecutor.

Issue notice to the Respondent No.2.

The learned counsel for the Petitioner is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

The petitioner is the wife of Respondent No.2. Respondent No.2 alleges that his wife, along with her relatives, committed theft of certain gold ornaments and clothes.

Considering the facts and circumstances of the case, the matter is referred to mediation.

Mrs.Ayyala Somayajula Lalitha Sundari, learned trained mediator is appointed as mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The Petitioner and Respondent No.2 shall appear before the mediator on 07.05.2026, or on any other date convenient to both parties and the mediator, and shall co-operate with the mediation.

The Mediator shall also conduct mediation in Crime No.211 of 2025, on the file of Mahila Urban Police Station, Guntur District.

The Station House Officer concerned is hereby directed to drive the parties before the learned trained mediator for amicable settlement.

Post the matter after Summer Vacation–2026, for the Mediator's report.

Until the mediation proceedings are concluded, there shall be a stay of all further proceedings in Cr.No.12 of 2026 on the file of Nagarampalem Police Station, Guntur District.
