

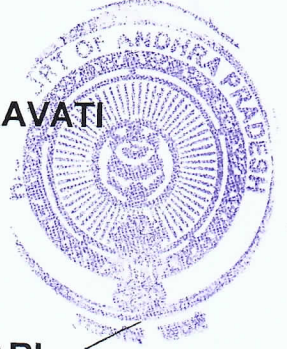

WHEREAS the Petitioner above named through her Advocate SRI A SYAM SUNDAR REDDY presented this Petition under Article 227 of the Constitution of India, praying that in the circumstances stated in the grounds filed herein, the High Court may be pleased to SET ASIDE the order dt.29-11-2024 passed in I.A.No.59/2020 in O.S.No.01/2017 on the file of Civil Judge (Senior Division), Avanigadda, Krishna District.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri A SYAM SUNDAR REDDY Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this CIVIL REVISION PETITION should not be admitted.

are be and hereby directed to show cause either appearing in person or through an Advocate, as to why in the circumstances set out in the petition and the grounds filed therewith (copy enclosed) this CIVIL REVISION PETITION should not be admitted.

The Court made the following: ORDER

"Heard Sri A.Syam Sundar Reddy, learned counsel for the petitioner.

- 2. The petitioner is the plaintiff. She filed the suit for grant of decree of declaration to declare that the plaintiff is the absolute owner of the plaint schedule property by cancellation of revocation deed dated 29.11.2016 executed by the defendant herself for plaint schedule property as also for the consequential permanent injunction. In the said suit, she filed I.A.No.59 of 2022 for amendment in the prayer clause. The same has been dismissed by an order dated 29.11.2024, which is impugned in C.R.P.No.1165 of 2025. The defendant sought to recover the possession.**
- 3. The plaintiff also filed I.A.No.472 of 2024 for deletion of certain part of the prayer already made. The said application has also been rejected. Challenging the same, C.R.P.No.1139 of 2025 has been filed.**
- 4. Issue notice to the respondent.**
- 5. In addition to the normal mode of service, the petitioner is permitted to take out personal notice to the respondent by registered post and acknowledgment due and file proof of service in the Registry before the next date of listing.**
