Petition under Section 528 of BNSS, 2023 is filed praying that in the circumstances stated in the memorandum of grounds of criminal petition, the High Court may be pleased to grant stay of all further proceeding pursuant to the order in F.C.O.P (MC) No.1881/2021 dt: 22/1/2026 on the file of The Court of the Judge, Addl. Family Court-Cum-XIV Additional District and Sessions Judge, Vijayawada, pending disposal of CRLRC.No.445 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and memorandum of grounds and the order of the High Court dated 07.07.2026 made herein and upon hearing the arguments of Ms. VARUPULA SESA KUMARI, Advocate for the Petitioner and PUBLIC PROSECUTOR for Respondent No.4, the Court made the following;

ORDER:

“The Petitioner and the Respondent No.1 are present.

The petitioner submits that he has paid an amount of Rs. 1,29,000/- through PhonePe to the account of Respondent No.1. He further submits that he has paid a sum of Rs.4,71,000/-in cash to Respondent No. 1.

The order dated 22.01.2026 passed by the learned Judge, Additional Family Court-cum-XIV Additional District and Sessions Judge, Vijayawada, is stayed, subject to the Petitioner depositing 50% of the arrears of maintenance, i.e., Rs.15,45,000/-, before the learned Trial Court within a period of three (03) months from the date of this order and continuing to pay monthly maintenance of Rs.10,000/- each to Respondent Nos.1 to 3, without default.

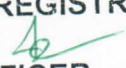
On such deposit, Respondent No.1 shall be at liberty to withdraw the amount. In the event of failure on the part of the Petitioner to deposit the aforesaid arrears within the stipulated time, the learned Trial Court shall be at liberty to proceed in accordance with law.

Smt. Koppaka Aruna, learned Counsel is appointed as learned Mediator in this case.

The Secretary, High Court Legal Services Committee is directed to issue necessary proceedings in this regard.

The Petitioner and the Respondent No.1 shall appear before the Mediator on 11.08.2026 or any other convenient date for both parties, without fail, for amicable settlement of the dispute between the parties.
