WHEREAS the Petitioners above named through their Advocate Sri Sasanka Bhuvanagiri, presented this Petition under Section 528 of BNSS, is filed praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to quash the

CC.No.78 of 2025 on the file of the Court of the Additional Junior Civil Judge Chilakaluripet against the petitioners herein;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri Sasanka Bhuvanagiri, Advocate for the Petitioners and of Public Prosecutor for Respondent No.1, directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

be and hereby are directed to show cause, either appearing in person or through Advocate, as to why in the circumstances set out in the petition and the grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

IA NO: 2 OF 2026

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay all proceedings against the petitioners herein in connection with CC.No.78 of 2025 the file of the Court of the Additional Junior Civil Judge Chilakaluripet, including their appearance, pending disposal of CRLP No. 3339 of 2026, on the file of the High Court.

THE COURT MADE THE FOLLOWING ORDER:

“Heard the learned counsel for the petitioners and the learned Assistant Public Prosecutor.

Issue notice to respondent No.2.

The learned counsel for the petitioners is permitted to take out personal notice on respondent No.2 and file proof to that effect.

The petitioners are the in-laws of Respondent No.2. After Accused No.1 filed a petition for restitution of conjugal rights, Respondent No.2 lodged a complaint against the petitioners, which was registered as Crime No.226 of 2024 on the file of the Station House Officer, Chilakaluripet.

Respondent No.2 alleges that, in the month of December 2022, she was necked out by the petitioners and her husband after being beaten, as she could not meet the unlawful demands of the petitioners. However, Respondent No.2 lodged the complaint on 04.10.2024, nearly two years later. Of course, the offence defined under Section 85 of 'the BNS' is continuous in nature.

Considering the entire facts and circumstances of the case, and the nature of the allegations levelled against the petitioners by Respondent No.2, the matter is referred to mediation.

Mr. Habeeb Sheik, learned trained Mediator, is appointed as the Mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The petitioners and Respondent No.2 are directed to appear before the learned Mediator on 08.05.2026 or on any other convenient date for the parties and the Mediator.

The learned Magistrate of the Trial Court and the Station House Officer concerned are hereby directed to drive the parties before the Mediator for amicable settlement.

Post the matter after Summer Vacation-2026, for Mediator's report.

Until the conclusion of the mediation proceedings, there shall be a stay of all further proceedings in C.C.No.78 of 2025 on the file of the learned Additional Junior Civil Judge, Chilakaluripet."
