Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or direction or order, more particularly one in the nature of a Writ of Mandamus, declaring the action of Respondent No.3 in attempting to dispossess the petitioner from the land, admeasuring Ac. 4.50 cents in Sy. No. 133-1A of Gangapuram Village, Kalakada Mandal, Annamayya District, respectively, as illegal, arbitrary, high-handed, and violative of the petitioners fundamental and constitutional rights guaranteed under Article 19(1)(g) and Article 300-A of the Constitution of India and consequently, direct Respondent No.3 not to interfere with the peaceful possession and enjoyment of the above-said land by the petitioner except by following due process of law;

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct Respondent No. 3 not to interfere with the peaceful possession and enjoyment of the petitioner from the land, admeasuring Ac. 4.50 cents in Sy. No. 133-1A of Gangapuram Village, Kalakada Mandal, Annamayya District, respectively, Pending disposal of WP 11370 of 2026, on the file of the High Court.

The petition, coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri SURESH KUMAR REDDY KALAVA Advocate for the Petitioner, GP FOR REVENUE for Respondent Nos.1 to 3 and the Court made the following.

ORDER

Heard the learned counsel for the petitioner and the learned Assistant Government Pleader for revenue for the respondents.

This writ petition is filed questioning the action of the respondent No.3 in attempting to dispossess the petitioner from the land admeasuring Ac. 4.50 cents in Sy. No. 133-1A of Gangapuram Village, Kalakada Mandal, Annamayya District.

The learned counsel for the petitioner submits that the pattadar passbook vide patta No.83 covering the subject land in an extent of Ac. 4.50 cents in Sy. No. 133/1A and the ROR 1b Report dated 23.02.2026 are standing in the name of the petitioner for the subject land. Now that the petitioner contends about the highhanded action of the 3rd respondent in threatening to dispossess the petitioner from the subject land.

In view of the above said facts and circumstances, there shall be an order status quo as on today to be maintained with respect to the subject land in an extent of Ac. 4.50 cents in Sy. No. 133-1A of Gangapuram Village, Kalakada Mandal, Annamayya District, till the next date of hearing.
