WHEREAS the Petitioner/Accused above named through his Advocate Sri SODUM ANVESHA presented this Petition under Sections 482 of Cr.P.C/528 of BNSS, is filed praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to call for the records in and relating to Crime No. 55/2026 of Srikalahasti II- Town Police Station, Tirupati District and quash the same in so far as the Petitioner is concerned

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri SODUM ANVESHA Advocate for the Petitioner, Public Prosecutor for R1

directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

P Bhavani Prasad, S/o V Pushparaj, Occupation Commissioner, Srikalahasti Municipality, R/o Plot No. 401, Mouryamanson, Royal Nagar, Tirupati District are be and hereby directed to show cause either appearing in person or through an Advocate as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

IA NO: 2 OF 2026

Petition under Sections 482 of Cr.P.C/528 of BNSS, is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay all further proceedings including arrest of the Petitioners in Crime No. 55/2026 of Srikalahasti II-Town Police Station, Tirupati District, pending disposal of CRLP No. 3348 of 2026, on the file of the High Court.

The Court made the following: ORDER

Heard learned counsel for Petitioner and learned Assistant Public Prosecutor.

Issue notice to the Respondent No.2.

The learned counsel for the Petitioner is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

The learned counsel for the Petitioner submits that the Petitioner lawfully inherited Ac.1.50 cents in Sy.No.28/4 through his grandmother Sarojamma. Revenue records, Pattadar Passbook, and Title Deed stand in his name, duly mutated and valid. Municipal and Collector endorsements confirm the land as patta land, not municipal property. Further, in W.P.No.24437/2026, a learned Single Judge of this Court directed restoration of his digital signature, which continues to reflect his ownership.

It appears that the provisions of the Andhra Pradesh Land Grabbing (Prohibition) Act, 1982 have not been properly followed by the de-facto complainant. Before lodging the complaint, no suit was filed or instituted by Respondent No.2. Respondent No.2, even though being the Commissioner of Srikalahasti Municipality, is competent to institute a land grabbing suit. However, it appears that the prescribed procedure has not been followed.

Until further orders, the Investigating Officer shall not take any coercive steps against the Petitioner.
