ORDER

The present interlocutory application was filed under Section 438 (1) of BNSS, 2023 by the petitioner to suspend the conviction and sentence dated 21.07.2023 passed in C.C.No.93/2021 on the file of learned Special Magistrate of First Class, Venkatagiri, SPSR Nellore District, which was confirmed vide Judgement dated 26.03.2026 passed in Crl.A.No. 132 of 2023 on the file of learned VII Additional District & Sessions Judge, Gudur, Nellore District and enlarge the petitioner/accused on bail, pending disposal of the main Criminal revision case. SPSR

Heard the learned counsel for the petitioner and the learned Assistant Public Prosecutor on behalf of the State.

In view of the submissions made, the sentence of imprisonment alone is suspended, pending disposal of the Criminal Revision Case on the following conditions:

- i. The petitioner herein is directed to surrender before the learned Special Magistrate of First Class, Venkatagiri, SPSR Nellore District, within one week from this day and, on such surrender, the petitioner shall be enlarged on bail on executing a personal bond for a sum of Rs.20,000/- (Rupees Twenty Thousand only) with two sureties for a like sum each to the satisfaction of the learned Special Magistrate of First Class, Venkatagiri, SPSR Nellore District, on the same day.

- ii. The petitioner shall appear before this Court as and when directed.
