SHASHI VARDHAN, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction one in the nature of writ of mandamus declaring the action of the respondents restricting the contract period to six months, contrary to Circular Memo dated 24.03.2026 and G.O.Rt.No.4271 dated 01.11.2008, as illegal, arbitrary discriminatory and violative of Article 14 of the Constitution of India, and consequently direct the respondents to grant/extend the contract period to one year;
