No. 11 of 2026, on the file of III Additional District and Sessions Court, Guntur and quash the same against the Petitioner/Accused No. 1 and 2;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri

RAMALAKSHMANA REDDY SANEPALLI, Advocate for the Petitioners, and of Public Prosecutor for Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

IA NO: 1 OF 2026

Petition under Section 528 of B.N.S.S., is filed praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to stay all further proceedings in S.C. No. 11 of 2026, on the file of III Additional District and Sessions Court, Guntur, pending disposal of CRLP No. 3390 of 2026, on the file of the High Court.

The Court made the following ORDER:

Heard learned counsel for the Petitioners and the learned Assistant Public Prosecutor.

Issue notice to the Respondent No.2.

The learned counsel for the Petitioners is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

The alleged offence in the instant crime, i.e., FIR No.468 of 2024, occurred on 18.04.2024 as per the version of Respondent No.2. However, he submitted a complaint to the Station House Officer, Tadepalli Police Station, Guntur District, on 14.10.2024, resulting in a delay of nearly six months. It is pertinent to note that Respondent No.2, in a rash and negligent manner, drove his bike and caused severe injuries to one

Meka Venkata Reddy, who later succumbed to the said injuries. This incident of rash and negligent driving by Respondent No.2 was registered as Crime No.211 of 2024 on the file of Tadepalli Police Station, Guntur District, on 19.04.2024.

Considering the facts and circumstances of the case, there shall be a stay of all further proceedings in S.C.No.11 of 2026 on the file of the learned III Additional District and Sessions Judge, Guntur.
