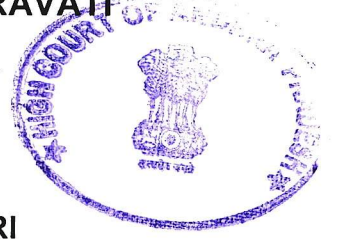

refer the parties for mediation.**
