Civil Judge (Junior Division), Court, Ponnur as illegal, arbitrary, unconstitutional, violative of basic human rights and also violative of article 14 and 21 of constitution of india and consequently direct the respondent no.2 to forthwith conduct enquiry against the high handed, illegal, anarchical acts of the respondent no.3 in respect to the harassment that is being caused to this petitioners and to take appropriate action against the respondent no.3 forthwith,

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of M/s PILLIX LAW FIRM Advocate for the Petitioners and GP for Home for respondent Nos. 1 to 3, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
