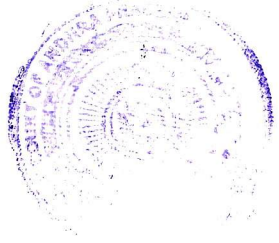

Till then there shall be stay of all further proceedings in E.P.No.40/2025 in O.S.No.448/2018 on the file of the learned Principal Civil Judge (Senior Division), Nellore on condition of the petitioner depositing 50% of the suit costs within one (1) week from today, failing which the interim order granted shall stand vacated automatically without reference to this Court.
