Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order, or direction, more particularly one in the nature of a Writ of Mandamus, declaring the actions of the respondents 2 and 3 in interfering with the petitioner's property, i.e., the vacant site admeasuring 299 square yards of house site bearing Plot No. 44 in R.S. Nos. 5/7, 5/8 and 5/11 of Machavaram Hamlet, Vullipalem Revenue Village, Machilipatnam, Krishna District, as illegal, arbitrary, and contrary to Articles 14, 19, and 300-A of the Constitution of India, and consequently directing the 3rd respondent not to interfere with the petitioners property without following due process of law,

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents 2 and 3 not to interfere with the petitioner's peaceful possession and enjoyment of the vacant site admeasuring 299 square yards of house site bearing Plot No. 44 in R.S. Nos. 5/7, 5/8 and 5/11 of Machavaram Hamlet, Vullipalem Revenue Village, Machilipatnam, Krishna District, Pending disposal of WP 11714 of 2026, on the file of the High Court.

The petition, coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri CHAKRAVARTHY P V S K Advocate for the Petitioner, GP FOR REVENUE for Respondent Nos.1 to 3 and the Court made the following.
